Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

The baseline emissions of Wessex were composed of 5 key elements:

1. Buildings

- a. Gas electricity

2. Travel

- a. Fleet vehicles
- b. Delivery vehicles
- c. Business travel


3. Waste

- a. General Waste
- b. Recycling

4. Water

5. Procurement

- a. Products
- b. Office Consumables

Additional Details relating to the Baseline Emissions calculations.

The 2021 baseline was the first period in which Wessex actively monitored emissions and the overall business output. Reporting methods were created, plans activated, and strategies implemented to proactively decrease greenhouse gas emissions.


Emissions reduction targets

Current reduction targets are in line with our goals to become carbon neutral by 2028 and Net Zero by 2040.

To continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets:

- 1.Reduce overall greenhouse gas output by 20% annually.
- 2.Use alternative fuel methods where possible for fleet vehicles for 10% of vehicles.
- 3.Reduce waste and increase levels of recycling by 15%.

We project that carbon emissions will decrease over the next five years to 140.7 tCO₂e by 2028. This is a reduction of 29%



Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 12.4 tCO₂e, a 6.4%ge reduction against the 2021 baseline.

- 1.Introduction of electric vehicles which now equate for 26% of our fleet.
- 2.Introduction of specific procedures to reduce building fuel consumption.
- 3.Introduction of renewable energy for dual fuels in our building operations
- 4.Introduce waste reduction measures
- 5.Control water consumption more
- 6.Introduce digital-first systems
- 7.Procure remanufactured office equipment where possible.
- 8.Register and commit through Planet Mark.
- 9.Maintain our partnership with Cool Earth to protect 100,000 hectares of rain forest

In the future we hope to implement further measures such as:



Software engineering for vehicles to reduce Co2 by 10% per vehicle where electric/hybrid is not viable



Make improvements to our building to reduce energy consumption and increase efficiencies.



Offset a percentage of Co2 through accredited bodies where a reduction is not possible.



Continue to invest in alternative fuel for vehicles.

Declaration and Sign Off

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 12.4 tCO₂e, a 6.4%ge reduction against the 2021 baseline.
